Besoek deur MK party 21 April 2025

Kleinfontein is vandag deur 'n afvaardiging van die MK party en media besoek. Daar was nie formeel kennis gegee van die MK Party se besoek nie en is gelei deur hulle hoofswep Mnr. Mzwanele Manyi.

Volgens Mnr. Manyi was die hoofdoel van die besoek 'n feite sending, na aanleiding van verskeie mediaberigte oor die Afrikaner gemeenskap.

Die MK afvaardiging is deur van Kleinfontein se bestuur te woord gestaan en artikel 235 het sterk gefigureer as besprekingspunt. Alhoewel die gesprek in goeie gees plaasgevind het, het die onderskeie party ooreengekom om mekaar se standpunte te respekteer ondanks duidelike ideologiese verskille. Kleinfontein se onafhanklikheid van Tshwane en die feit dat Kleinfontein geen dienste van Tshwane ontvang nie, is ook bespreek.

Na koeksisters, koffie en tee, is die afvaardiging op 'n kort begeleide toer deur Kleinfontein geneem. Besoek is afgelê by van Kleinfontein se munisipale infrastruktuur soos die drinkwater aanleg en rioolwerke waarna die besoekers via die historiese Engelse begraafplaas teruggekeer het.

In 'n finale Media onderhoud by Kleinfontein se ingangspoort, het Mnr Manyi beklemtoon dat MK beplan om vroeër eerder as later, 'n voorlegging in die parlement te maak, wat meer substansie aan artikel 235 sou verleen.

Visit by MK Party – 21 April 2025

Kleinfontein was visited today by a delegation from the MK Party and the media. No formal notice of the MK Party's visit was given, and it was led by their Chief Whip, Mr. Mzwanele Manyi.

According to Mr. Manyi, the main purpose of the visit was a fact-finding mission following various media reports about the Afrikaner community.

The MK delegation was addressed by members of Kleinfontein's management, and Article 235 featured prominently as a discussion point. Although the conversation took place in a good spirit, both parties agreed to respect each other's viewpoints despite clear ideological differences. Kleinfontein's independence from Tshwane, and the fact that Kleinfontein receives no services from Tshwane, were also discussed.

After enjoying koeksisters, coffee, and tea, the delegation was taken on a short, guided tour of Kleinfontein. Visits were made to some of Kleinfontein's municipal infrastructure such as the drinking water plant and sewage works, after which the visitors returned via the historic English cemetery.

In a final media interview at Kleinfontein's entrance gate, Mr. Manyi emphasized that the MK Party plans to make a submission sooner rather than later that would give more substance to Article 235.
